SCOPE OF INSURANCE COVER

Risks covered	Damages of the display of your insured device e.g., breakage due to drop or falling down.
Events insured	Screen damages: Repair costs.
Devices insured	Mobile Phone or Tablet registered together with the Sim Card purchased at SALT.
Insured events	Maximum 1 claim within 12 months.
Exclusions	Exclusions are listed in item 9 of the GCI, such as damages not limited to the Insurance Device, cosmetic damages, intentional and gross negligence

Payment	Monthly with the Salt bill

CONTRACT PERIOD & CLAIM OBLIGATIONS

Contract start	Start date according to insurance confirmation (date of conclusion of insurance contract) Your insurance cover begins 30 days after the date of the subscription to the insurance policy.
Contract duration	The insurance contract runs for a minimum period of 24 months, unless cancelled within the first 14 days. More details are available under items 1 and 6 of the GCI
Claim fulfilment	Fast replacement of the damaged screen of your Insured Device.
Excess fee	CHF 99 per claim and insured device.
Claim notification	Claim notification at our insurance partner bolttech: www.caresupport.ch
Obligations	In case of a claim, you have several information and obligations listed in item 12 of the GCI of Salt Keep & Care, such as a complete and true claim notification, unlocking of your device and provision of requested documents

Without the processing of your personal data, it is not possible for you to obtain insurance cover or for us to carry it out. The Insurer and bolttech require your personal data for the purpose of processing the insurance contract (including claims processing, payment of benefits and debt collection). | The data is processed in accordance with the applicable laws - namely the Swiss Federal Data Protection Act (DSG) for clients in Switzerland and the GDPR for clients in the Principality of Liechtenstein
